# Suncorp closes Capital Notes 5 Offer raising \$360 million

Suncorp Group Limited (ASX: SUN | ADR SNMCY) (**Suncorp**) today announced it has successfully completed the Capital Notes 5 Offer (**Offer**), raising \$360 million through the issue of 3.6 million Capital Notes 5 for \$100 each. Capital Notes 5 have been issued to raise Eligible Additional Tier 1 Capital, the proceeds of which Suncorp expects to use to fund the capital needs of one or more Regulated Entities within the Suncorp Group and for general corporate and funding purposes.

Suncorp has also confirmed the allocation policy applicable to the Offer and the Distribution Rate applicable to the first Distribution in respect of Capital Notes 5, which is expected to be paid on 17 September 2024.

### **Allocation Policy**

Allocations under the Offer to Syndicate Brokers and Institutional Investors were determined under the Bookbuild announced to the market on 18 April 2024. Allocations to individual Applicants by each Syndicate Broker were at the discretion of the relevant Syndicate Broker, with priority given to Applicants under the Reinvestment Offer. Applicants should confirm their allocation of Capital Notes 5 under the Offer with their Syndicate Broker. Institutional Investors have already been advised of their allocations.

## Trading on the ASX and confirmation of holdings

Capital Notes 5 were issued today and are expected to begin trading on the Australian Securities Exchange (**ASX**) on a normal settlement basis on 15 May 2024 under the ASX code "SUNPJ".

Applicants are responsible for determining and confirming the number of Capital Notes 5 allocated to them before selling any Capital Notes 5. Applicants who sell their Capital Notes 5 before receiving their CHESS transaction confirmation statements or issuer sponsored Holding Statement do so at their own risk. CHESS transaction confirmation statements and issuer sponsored Holding Statements, which state the number of Capital Notes 5 issued to successful Applicants, are expected to be dispatched to successful Applicants by 16 May 2024.

### **First Distribution**

Distributions on Capital Notes 5 are scheduled to be paid on 17 March, 17 June, 17 September and 17 December each year (or the next Business Day if not a Business Day), subject to the Capital Notes 5 Terms. The first Distribution of \$1.7327 per Capital Note 5 is expected to be paid on 17 September 2024 (subject to no Payment Condition existing). Payment of Distributions are at the absolute discretion of Suncorp. The first Distribution is expected to be fully franked.

The Distribution Rate for the first Distribution payment, which is for the Distribution Period from (and including) 14 May 2024 and ending on (but excluding) 17 September 2024 (being a period of 126 days), will be 5.0192% per annum.

The Distribution Rate has been determined under the Terms of the Capital Notes 5 (as contained in the Prospectus) as follows:

#### **Maximum Conversion Number**

For the purposes of the Conversion calculations, the Issue Date VWAP is \$16.20 and the initial Maximum Conversion Number is 12.3457 with respect to Mandatory Conversion, and 30.8642 with respect to Conversion in all other circumstances. The Maximum Conversion Number may be adjusted at a future date in relation to divisions or consolidations of Ordinary Shares (among other matters) in the manner described in the Prospectus.

#### Participation by Suncorp Directors and their related persons

Suncorp Directors and their related persons (being their spouses, parents, children and associates) did not participate in the Offer.

### Resale of Participating Capital Notes 2

Today, the Capital Notes 2 in respect of which Eligible Capital Notes 2 Holders elected to participate in the Reinvestment Offer (approximately 200 million) were resold to the Nominated Purchaser for \$100 per Capital Note 2 and the Resale Proceeds of which, were applied towards the Eligible Capital Notes 2 Holders' Application Payments for subscription for the corresponding number of Capital Notes 5. All Participating Capital Notes 2 that were transferred to the Nominated Purchaser were subsequently redeemed by Suncorp.

Following the completion of the Reinvestment Offer, approximately \$175 million of Capital Notes 2 (ASX: SUNPG) remain on issue.

### **Capital Notes 2 Distributions**

The First Pro Rata Distribution of \$0.8749 fully franked in respect of Capital Notes 2 has today been paid on all Capital Notes 2 held on the record date of 30 April 2024, regardless of whether Capital Notes 2 have been reinvested in Capital Notes 5.

All remaining Capital Notes 2 Holders (being Capital Notes 2 Holders who chose not to participate in the Reinvestment Offer) who hold Capital Notes 2 on the record date of 31 May 2024, will receive the Second Pro Rata Distribution of \$0.5219 fully franked on 17 June 2024 (subject to no payment condition existing, as defined in the Capital Notes 2 Terms (as amended)).

All payments have been, or will be, made in accordance with the payment instructions recorded for a Capital Notes 2 Holder on the Capital Notes 2 register.
