"Asteron is optimistic about the future of advice in the life risk market. This is the reason we have chosen to run hard at the FoFA flame. We have worked relentlessly to take a position on key elements on the Government's reform package - in particular the removal of risk commissions under super - and recently developed a lobbying pack that many advisers, and our own staff, have used with their local members.

"As a life risk specialist aligned to IFAs, we are committed to this industry and its future - and partnering with advisers to help them navigate successfully through these changes is a key strategy to help IFAs build a stronger future.

"Key to our industry's success is the need for <u>self-regulation</u>. The FSC's announcement last week to manage insurance 'churn' by removing takeover terms and applying a two-year responsibility period should be commended. However, any reform on replacement business should be about ensuring *quality advice*, and not penalising good advisers in the industry who do not engage in churn."
